Kemp Mill Estates Sidewalk Project

Project to Begin tentatively Monday, November 9th

PURPOSE

This newsletter is to inform you of the upcoming sidewalk installation on the following roadways:

- North side of Hermleigh Road from Stonington Place to Kemp Mill Road;
- South side of Stonington Place from Lovejoy Street to Hermleigh Road;
- East side of Lovejoy Street from 11525
 Lovejoy Street to Stonington Place;
- ♦ The path between Lovejoy Street and Auth Lane located between 11710 Lovejoy Street and 11712 Lovejoy Street and extending between 11725 Auth Lane and 11729 Auth Lane.

Please see Project Map located on the reverse side of this newsletter.

BACKGROUND

The Annual Sidewalk Program is a section of The Montgomery County Department of Transportation's (MCDOT) Division of Transportation Engineering (DTE). The afore-mentioned sidewalk was proposed to the impacted and



neighboring residents on August 6, 2019 and was the subject of a Public Hearing on April 22, 2020. On June 24, 2020, the Recommendations approving the sidewalk installation were signed by Director, Christopher Conklin.

SCOPE OF PROJECT

A 5-ft-wide concrete sidewalk with a variable 0 to 3-ft greenspace will be constructed on the above-referenced roadways.

SCHEDULE

This project is scheduled to tentatively begin Monday, November 9, 2020. Construction will start on Lovejoy Street. Weather permitting, the project will take 3 to 5 weeks to complete, and may be completed in 2 segments, the second

segment beginning in Spring 2021. Residents will be informed if and when the work will be broken into segments. Work hours will be between 7am and 5pm, Monday through Friday.

PROJECT WORK PLAN

Generally, the work will proceed as follows:

- Tree Removal— The trees that are slated for removal will be removed beginning on or about Monday, November 2, 2020. Construction may take place simultaneously. No parking signs will be placed around the subject trees prior to removing.
- Markings in Right of Way & No Parking Signs - Sidewalk locations will be marked out in white paint in the public right-ofway. No parking signs will be erected along the limits of sidewalk installation.
- Excavation for Setting of Sidewalk
 Forms— The excavation will begin for sidewalk construction and the placement of concrete forms for the pouring of concrete sidewalk, lead-walks and driveway aprons,



if applicable.

 Pouring of Concrete— Once concrete has cured, the forms will be removed and top-

- soil, seed and straw will be add to backfill to meet with existing grade.
- **5. Sealant** A sealant will be sprayed upon sidewalk and driveway aprons to preserve and protect the sidewalk from harsh winter chemicals.
